## NARRATIVE

ON LISTED DATE AND TIME, WHILE ASSIGNED TO STREET CRIMES UNIT, I OBSERVED DEFENDANT MESTRE ARMED WITH AN OPEN POCKET KNIFE (SILVER METAL) ENGAGED IN A HEATED VERBAL ALTERCATION WITH V-1 (REDDING) IN THE ALLEY JUST WEST OF 16435 NE 15 AVE. I OBSERVED DEFENDANT MESTRE MAKING LOUD VERBAL THREATS TO THE V-1 (REDDING) WHO WAS APPROXIMATELY TEN FEET AWAY. SPECIFICALLY, DEFENDANT MESTRE STATED, "IM FROM THE HOOD MY NIGGA", "I KNOW HOW TO USE THIS SHIT" WHILE HOLDING THE POCKET KNIFE FIRMLY BY HIS SIDE. PRIOR TO EXITING MY UNMARKED VEHICLE, SOMEONE IN THE CROWD YELLED, "POLICE" AND IMMEDIATELY THEREAFTER, DEFENDANT MESTRE PLACED THE KNIFE UNDER THE DRIVER SEAT OF HIS SILVER TOYOTA BEARING FLORIDA TAG (PB8HX). I THEN REQUESTED BACKUP AND PROCEEDED TO VERBALLY CALM THE PARTIES INVOLVED. V-1 (REDDING) WAS NOT ARMED WITH ANY WEAPONS DURING THE VERBAL ALTERCATION. INVESTIGATIONS REVEALED THAT THE ARGUMENT ENSUED OVER A CAR BEING REPOSSESSED. DEFENDANT MESTRE IS AN EMPLOYEE FOR PRESTIGE AUTO TOWING WHO WAS TASKED TO REPOSSESS A KIA BEARING FLORIDA TAG (ECV F43) THAT WAS PARKED IN THE ALLEYWAY IN-QUESTION. V-1 (REDDING) STATED THAT HE WAS IN FEAR FOR HIS LIFE. DEFENDANT WAS PLACED UNDER ARREST AND TRANSPORTED TO NMBPD BY OFFICER BOURBON.

IT SHOULD BE NOTED THAT A YOUNG CHILD IO-2 (MEDEROS) WAS IN THE BACK SEAT OF THE DEFENDANT'S VEHICLE SLEEPING (NO CAR SEAT) DURING THE ENCOUNTER. THE CHILD WAS DRIVEN TO NMBPD BY LEAD DETECTIVE J. MOORE AND NMBPD VICTIM ADVOCATE RENEE DARDEN TO REUNITE WITH HIS MOTHER IO-1 (MEDEROS). INVESTIGATIONS REVEALED THAT DEFENDANT MESTRE AND IO-I (MEDEROS) ARE IN A RELATIONSHIP. TODAY, DEFENDANT MESTRE WAS TASKED WITH TAKING CARE OF THE CHILD. THE DEPARTMENT OF CHILDREN AND FAMILIES WAS INFORMED (CHASSIDY #531) OF THE INCIDENT.

AN INVENTORY OF THE DEFENDANT'S VEHICLE INCIDENT TO ARREST AND TOW REVEALED A KNIFE UNDERNEATH THE DRIVER SEAT DISCOVERED BY DETECTIVE WINCHESTER. DETECTIVE WINCHESTER THEN TRANSFERRED CUSTODY OF THE KNIFE TO DETECTIVE DIAZ WHO ALONG WITH DETECTIVE R. FLORENCIO SEALED IN PLASTIC FOR STORAGE. THE KNIFE WAS IMPOUNDED INTO NMBPD PROPERTY AS EVIDENCE.

NO PHYSICAL INJURIES OCCURED. DEFENDANT MESTRE WAS READ MIRANDA BY DETECTIVE DIAZ PER SHEET. POST MIRANDA, DEFENDANT MESTRE PROVIDED A WRITTEN STATEMENT ADMITTING TO ARMING HIMSELF WITH A KNIFE DURING THE HEATED VERBAL ALTERCATION WITH V-1 (REDDING). DEFENDANT MESTRE STATED THAT HE ARMED HIMSELF WITH THE KNIFE TO PROTECT THE CHILD. THE SIGNED MIRANDA FORM AND STATEMENT FORM WERE SUBMITTED TO NMBPD RECORDS DEPARTMENT.
